# NOTICE OF NOMINATIONS AND ELECTION FOR DELEGATES TO ATTEND THE INTERNATIONAL UNION CONVENTION THAT WILL CONVENE IN CHICAGO, ILLINOIS ON SEPTEMBER 28, 2020

The purposes of the 2020 IU Convention include the election of International Union Officers: President, Secretary-Treasurer, and two Executive Vice Presidents; and election by region of the Regional Vice Presidents to serve on the IU Executive Council. Because of the coronavirus pandemic, in accordance with Code 2 of IU Constitution, and with approval of the International Union Executive Board, we will be using a mail-based procedure for the delegate nomination and election process.

Our Local Union is entitled to send between zero (0) and four (4) delegates to the 2020 IU Convention. One (1) officer – our President – has been elected to a position designated by our Local Union Constitution as delegate by virtue of office.

The first question for our membership to decide is how many delegates, if any, to send to the Convention. The Management Committee recommends, and it has been moved by President Geoff Higginson, that this Local Union send one (1) delegate, and no alternates. Because this motion is to send a number of delegates that is less than or equal to the Local Union's properly designated delegates by virtue of office, if the motion is approved, the nominations and election for delegates to the 2020 IU Convention will be complete.

Enclosed with this Notice is a Ballot on which members should indicate whether they agree with the motion. Also enclosed is a pre-addressed envelope to return the Ballot, which must be received by the Local Union in the enclosed envelope no later than 5 pm on May 26, 2020.

The results of this membership vote on this Motion will be posted on the Local Union webpage <a href="http://blog.bac2bc.org/member-info/nominations-election-of-delegates-to-attend-international-union-convention/">http://blog.bac2bc.org/member-info/nominations-election-of-delegates-to-attend-international-union-convention/</a> and on a recorded voice mail message available by calling 604-584-2021 ext. 225 on May 26, 2020. Any protest must be filed in writing with the Local Union Election Committee postmarked no later than 5 pm on May 28, 2020.

If this motion is not passed, a second ballot, to determine the number of delegates, if any, to send to the 2020 IU Convention, will be mailed along with nomination forms, on June 1, 2020. Those ballots and nominations would be due June 16, 2020. If that process results in more members being nominated than delegate positions to be filled, an election will be conducted via mail ballot distributed on June 23, 2020, and due on July 8, 2020. If these steps are necessary, further instructions will be included with those mailings.
