

NOMINATION AND ELECTION NOTICE  
Bricklayers and Allied Craftworkers Local 2 British Columbia

NOMINATIONS

Because of the coronavirus pandemic, and in the interest of member safety, Local 2 will be using a special mail-based nomination procedure this year. Enclosed with this NOTICE are forms to be used to make/accept nominations for the offices of President, Secretary-Treasurer and three (3) Vice Chairpersons as well as for Chapter Chair in all four Chapters. The terms of office will commence on July 1, 2020 and will run until June 30, 2023. The President will serve as a delegate by virtue of office to the 2020 IU Convention.

As provided in the Local 2 Constitution and By-laws, any member in good standing\* (dues paid through March 31, 2020) including apprentices who have been members in good standing\* for at least one year, may nominate another member in good standing\*. A member may be a candidate for office only if he or she: (1) has been a journeyman member continuously in Local 2 and in the International Union for two years immediately prior to nomination; (2) is current in dues; (3) is not barred from office; and (4) is not a contractor or supervisory member. Apprentices may not hold Union office or position.

If you wish to nominate a journey-level member in good standing\* to serve in any of these offices, please write the name on the line provided. Potential Candidates must complete the enclosed Acceptance form to indicate their acceptance of nomination. Nomination and Acceptance forms must be signed, dated and include your IU number.

**Your completed Nomination and/or Acceptance forms must arrive at the post office box in the enclosed, pre-addressed envelope by 5 PM on May 26, 2020, so please allow at least three days for mailing.**

The Election Committee will review the nomination and acceptance forms. If an acceptance form is not received for a nominee then the election committee will reach out by telephone on May 26, 2020 to all nominated candidates in the order of nominations set out in the constitution (Article XI.1.A.(6)) and alphabetically by position to see (confirm) if they will accept the nomination. A list will be posted of all eligible nominees on the Local Union webpage <http://blog.bac2bc.org/member-info/nominations-for-local-and-chapter-officers/> and on a recorded voice mail message available by calling (604) 584-2021, EXT. 225 on May 26, 2020.

**Members wishing to protest the nomination process or the qualification of any nominee must do so by May 28, 2020 via fax to the Election Committee at (604) 584-2022.**

ELECTION

An election, if one is necessary, will be held by mail referendum. In such case, the ballots will be mailed out no later than June 3, 2020 and must be returned so that they are received at the post office box designated on the return mailing envelope no later than June 18, 2020. The ballots will be counted at 12309 Industrial Way, Surrey on June 19, 2020. Any member in good standing\* (dues paid through April 30, 2020) shall be eligible to vote and have his or her ballot counted, except contractor and supervisory members.

\*Any member wishing to pay dues in arrears will be able to do so up until the close of business the day Nomination Forms are reviewed, or for the election, the day ballots are counted, in either case before the Election Committee begins its review. Pay by EFT (e-transfer), Cheque in Envelope thru mail slot, at office in person wearing N95 mask.
